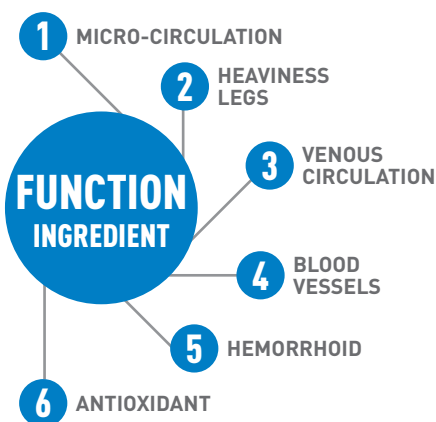

FEATURES

Capillarex® contains several natural substances: Diosmin, citrus' Hesperidin, with Vitamin C and Bromelain, pineapple's enzyme. Product contains also Vitis Vinifera dry extract, seeds and Ruscus aculeatus dry extract, natural substances active on micro-circulation, venous circulation and blood vessels. Capillarex® does not contain gluten (Gluten Free), therefore it is suitable also for people suffering from celiac disease or gluten intolerance.

INDICATIONS

Good effect on venous³ circulation and contrasts hemorrhoids⁵ thanks to Ruscus Aculeatus. It helps microcirculation¹, heaviness legs² and cardiovascular apparatus thanks to Vitis Vinifera seeds. Regular collagen formation helping blood vessels⁴ thanks to Vitamin C. Antioxidant effect⁶ thanks to Vitis Vinifera seeds and Vitamin C.

HOW TO USE AND RECOMMENDED DAILY DOSE

Take 1-2 tablet per day, preferably between meals. We recommend repeating a 2-3 month treatment cycle to maximise results.

INGREDIENTS

Diosmin from sweet orange (Citrus sinensis (L.) Osbeck, fruit), bulking agent: cellulose, Hesperidin (Citrus aurantium Fruit), Vitis vinifera var. tit 95% in OPC (Oligomeric Proantho Cyanidins) (Vitis vinifera, seed), L-ascorbic acid (vitamin C), butcher's-broom (Ruscus aculeatus L.) root e.s. tit. 10% Ruscogenine, Bromelain 2500 GDU/g (pineapple comosus L. Merr. stipite), Anti-caking agents: magnesium salts from fatty acids, silicon dioxide; Glazing agent: hydroxypropyl methylcellulose, glycerol, hydroxypropyl cellulose, coloring: titanium dioxide.

Warnings: this product is supposed to be used as part of a varied, balanced diet and a healthy lifestyle. Do not exceed the recommended daily dosage. Keep out of reach of children under 3 years. Do not take in pregnancy. Nutritional supplements are not intended as a substitute for a varied diet. Store in a cool, dry place. The expiration date applies to the product in its intact container when stored as directed. This product is tested free from Nandrolone and Testosterone with their precursors, free from Beta2-agonists, amphetamines and ephedrine.
